# I'm Claiming Helaman 10:4-7

Yesterday (2/16/23), when sending Kari Lake a copy of the editorial I wrote yesterday, "I Failed 'Be a Light' Opportunity to Defend 303 Creative Case Before SCOTUS"; I wrote a cover letter that I realized, later, should be turned into a [IndComing.com](http://IndComing.com) Blog post.

As I was writing to Kari, I realized that there was a very significant double synchronicity that ~~there~~ <sup>gave</sup> ~~was~~ an important divine witness of a significant impression I received yesterday morning. I went on "transport" (2 officer escort in a car) to the University of Utah to visit with Dr. Wahl of Endocrinology. While waiting in a holding cell before and after, as well as during the transport, I worked on memorizing Hel. 10:4-7. I had written on a 3x5 card a couple of years prior with my stack of verses to memorize/refresh when I'm in situations like this.

As I worked on memorizing it, I received a strong impression that this now applies to me - with an antonym substitution in verse 6 - and that I should fully embrace it as speaking of/to me, now. In the citation below, I'll strike through the words in verse 6 and show the word I see substituting it in my case.

"4 Blessed art thou, Nephi [Sterling], for those

things which thou hast done; For I have beheld how thou hast with unweariness declared the word, which I have given unto thee [my prolific writings], unto this people. And thou hast not feared them; and hast not sought thine own life, but hast sought my will, and to keep my commandments.

5 And now, because thou hast done this with such unweariness; behold, I will bless thee forever; and I will make thee mighty in word and in deed, in faith and in works; yea, even that all things shall be done unto thee according to thy word, for thou shalt not ask that which is contrary to my will. [Whenever I make a request that is unusual, e.g. to tp a letter or otherwise speed its delivery, I qualify it with, "Thy will be done, in thy timing, which is best."]

6 Behold, thou art Nephi [Sterling], and I am God [above]. Behold, I declare it unto thee in the presence of mine angels [e.g. my guardian angel contingent], that ye shall have power over ["with" - ChofFB joint heirs] this people, and shall smite ["heal" - per 2 Chron. 7:14 - if they repent, "I will heal their land"] the earth with ["from"] famine, and with ["from"] pestilence, and [from]

destruction, according to the wickedness ["repentance" - r.c.] of this people.

7 Behold, I give unto you power, that whatsoever ye shall seal on earth shall be sealed in heaven [as above, so below]; and whatsoever ye shall loose on earth shall be loosed in heaven [Compare Matt. 16:19 "keys of the kingdom" given to Peter, the rock; Isa. 22:22, p. 888, "the key of the house of David"]; and thus shall ye have power among this people [through the Millennium (JST-Luke 3:8,9 (in the Appendix) "the keys of the kingdom shall be delivered up again unto the Father... in the day that he shall come."; D&C 113:5,6, the root of Jesse in Isa. 11:10,11 (again the second time Messianic advent elaborated in 2 Ne. 6:13,14 & 7:2; D&C 133:66,67,72; 2 Ne. 28:32 & 29:1) > given the keys of the kingdom.)]."

The double synchronicity comes from (A) my being driven to the UoFU yesterday, followed by attending the UoFU Const. Law class in the evening; and (B) the antonym sentiment of the editorial in contrast to the "unwearingly declaring" sentiment of Hel. 10:4-7. I see that double synchronicity as a divinely orchestrated confirmation of the strong impression I received that morning, when memorizing Hel. 10:4-7, that this now applies to me.

<Moving beyond my letter to Kari> Those ref.s I was just citing also relate to what I said in my edi-

torial yesterday:

"(I found out last week that my mother is a direct descendant of Mary Magdalene [wife of Jesus and mother of his daughter], as are many others per O&C 86:8,9.)"

That ref. comes in the context of the separation of the wheat & tares (86:1-7) in this day of the "great division among the people" (2 Ne. 30:10) which in the r.c. concludes with the baptism of fire and of the Holy Ghost - mighty change of heart conversion of the wicked, willfully.

"8 Therefore, thus saith the Lord unto you, with whom the priesthood hath continued through the lineage of your fathers [ & mother - Mary Magdalene ] -

9 For ye are lawful heirs [ joint heirs, ChofFB once they get all-in, synced up - as necessary prerequisite for all ChofFB ], according to the flesh, and have been hid from the world [ Isa. 49:2 "in the shadow of his hand hath he hid me" ] with Christ [ 's offspring ] in God -

10 Therefore your life [ Ps. 118:17,18 "I shall not die"; Job 33:25. Fountain of youth ] and the priesthood have remained and must needs remain through you and your lineage until the restitution of all things [ Acts 3:21 (22 prophet like Moses - again the second time) ] spoken by the mouths of all the holy prophets since the world began.

11 Therefore, blessed are ye if you continue in my

goodness, a light unto the Gentiles [Isa. 11:10,11]  
and through this priesthood, a savior unto my  
people Israel ["H3478 he shall rule as God:-  
Israel" (Str:07)]...

In my letter to Kari, I mentioned what seems  
to be a restoration of my pancreas' ability to produce in-  
sulin despite being a type 1 diabetic (producing no insu-  
lin). I've been doing a fast of sorts since 1/12 to get  
some kind of response from Kari, either saying, (A) "I'm  
seriously reviewing your material," or (B) a hard "No."  
Before the fast, my long-acting dosage (to cover bas-  
al metabolism which would continually drive the  
blood sugar up, without the insulin) was 9 & 10  
units, am & pm, respectively. Now, it's less than 4 & 4,  
which I took yesterday and still was too much. The re-  
duced insulin<sup>need</sup> trend seems to be continuing.

I have long thought — since my pancreas be-  
gan recovering four years ago — that the final stretch<sup>th</sup>  
of healing (has been plateaued for 3+ years) would  
come just before I'm t<sup>h</sup>id out of here to be with  
HMIF (e.g. Kari, if she will) when we activate the  
II, once she's all in with this mission.

Here's hoping! ☺ Maybe we're on the brink  
of the r.c. & II launching in earnest.
